RULES AND REGULATIONS FOR THE VENDORS REGARDING THE PANAFEST EXPO

1. The organizers shall be responsible for the construction of stands (i.e. the canopy, skeletal divisions and the provision of light only) and the general preparation of the fair grounds.
2. The organizers will not provide accommodation for vendors.
3. Vendors shall be responsible for displaying their product and to make their stands ready for opening ceremony.
4. No vendor shall obstruct any passage way.
5. No vendor shall temper with any electrical installations in the stands without the permission of the fair organizers.
6. All sales should be confined in the stands. No vendor should roam the fairgrounds marketing their products or services.
7. The fair organizers shall not provide storage facilities (space) for vendors.
8. The organizers will provide general site security but will not be liable for any lost or damage of materials at the grounds.
9. The use of hazardous materials (such as acid, petroleum product, highly inflammable materials etc.) is prohibited.
10. No Vendor shall engage in any activity to degrade the environments (i.e. cutting of trees, digging of holes or trenches, burning etc.)
11. Vendors with electrical gadgets such as refrigerators, popcorn machines, microwaves etc. will have to disclose it to the organizers for an additional fee. Vendors who fail to disclose, will be made to pay four times the fee as penalty.
12. Payments made to the Foundation are NOT REFUNDABLE
